**CONDITIONS:** Permittee shall notify the Wyoming Game and Fish Department in writing upon any death, birth, escape or transfer of the permitted wildlife. In the event permittee moves to a new residence (current address: 2602 W. Cottonwood Cr. Rd Thermopolis, WY), the permittee is to contact the local Game and Fish Regional Office and schedule a facility inspection of the new location with the local Game Warden. It will be the permittee's responsibility to ensure the public's safety at all times. Bobcats shall be obtained from the wild, within Wyoming. Once bobcats are kept in possession they shall not be released to the wild. Permittee shall maintain adequate cage size for each bobcat as per wildlife rehabilitator cage guidelines and facility shall be inspected and approved by a game warden prior to possession of bobcats.

**PURPOSE:** Pet, Sell,

The permit holder shall adhere to all conditions of the application and permit, Wyoming statutes and Commission regulations. This permit is valid only for the permit holder named above and in accordance with the specified requirements. Disposition of live wildlife will be in accordance with Chapter 10 regulation. A new Chapter 10 application form must be submitted and approved PRIOR to obtaining any new wildlife.

In accordance with Chapter 10 commission regulation, the permittee shall maintain current records for the term of the permit on forms prescribed by the Department. Such records shall be completed accurately and legibly. Original records shall be kept at the holding facility. Records, facilities and wildlife are subject to Department inspection at any time.
